ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION OF  
WEDDING PROFESSIONALS OF CENTRAL FLORIDA, INC.

FIRST

Article II is hereby amended to read:

The purposes for which the corporation is organized are exclusively as a business league within the meaning of section 501(c)(6) of the Internal revenue code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

Notwithstanding any provision of these Articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under section 501(c)(5) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. No part of the net earnings will inure to the benefit of any private shareholder or individual. The corporation is not organized for profit or organized to engage in an activity ordinarily carried on for profit.

The general purpose of the corporation shall be to promote the common business interests of wedding professionals.


