ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION OF

BOOK OF HOPE, INC., a Florida corporation, not for profit



Pursuant to the provisions of Section 617.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is BOOK OF HOPE, INC., a Florida not for profit corporation.
- The following amendment of the Articles of Incorporation was adopted by a majority of the Board of Directors of the corporation on the 25 day of February, 1999 in the manner prescribed by the Florida Statutes and pursuant to Audie XI of the Articles of Incorporation which states that an amendment may be proposed by any Member of the corporation, but such amendment may be adopted only after receiving an affirmative vote of the majority of the Board of Trustees: A vote of the Membership is not required.

Article I is hereby deleted in its entirety and replaced by the following:

ARTICLE I

Name and Location of Principal Office

The name of the corporation is **Book of Hope USA**, **Inc.**, a Florida corporation, not for profit. Its office shall be located at 3111 S.W. 10th Street, Pompano Beach, Florida 33069.
