"I. The name of the corporation is WILLIAMS MEMORIAL CHURCH OF THE LIVING GOD, INC."

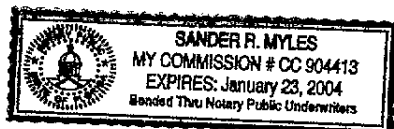
2. The foregoing amendment was adopted by the Board of Trustees and Directors of the corporation on the June 1, 2001.
