ARTICLES OF AMENDMENT  
TO THE  
AMENDED AND RESTATED  
ARTICLES OF INCORPORATION  
OF  
THE ORTHODOX CHRISTIAN MISSION CENTER, INC.  
(A Non-Profit Corporation)

Pursuant to the provisions of section 617.1006, this Florida Not For Profit Corporation adopts the following amendment to its Amended and Restated Articles of Incorporation, pursuant to actions taken by the Board of Directors:

1. Section 2.3 of Article II is deleted in its entirety and the following substituted in lieu thereof:

Section 2.3. Dissolution: Upon the dissolution or liquidation of this Corporation, any assets remaining after payment, or provision for payment, of all of its debts, obligations, and liabilities shall be distributed (1) to the Assembly, if such Corporation is then organized and operated exclusively for charitable purposes and has established tax-exempt status under Internal Revenue Code §501(c)(3) or the corresponding section of any future federal internal revenue law; or (2) if the Assembly does not qualify under the foregoing clause, to a nonprofit fund, foundation, or corporation that is organized and operated by a self-described Christian organization exclusively for charitable purposes and that has established tax-exempt status under Internal Revenue Code § 501(c)(3) or the corresponding section of any future federal internal revenue law, in either case to enhance or underwrite international Orthodox Christian missions with which OCMC has been active; provided, the restrictions of all "donor restricted funds" will be honored, and, if this is not possible, said funds will also be distributed to enhance or underwrite international Orthodox Christian missions with which OCMC has been active in consideration of the stated purpose of said funds.

2. There are no members or members entitled to vote on the amendment. The amendment was adopted by the board of directors on January 31, 2022.

3. In all other respects, except as specifically changed and modified in these Articles of Amendment, all of the provisions contained in the Amended and Restated Articles of Incorporation of The Orthodox Christian Mission Center, Inc. shall be and remain the same.
