Resolved, that the assets of the Corporation be distributed to the following corporations in the percentages noted, all distributors being 501 (c) (3) corporations under the regulations of the Internal Revenue Service and non-profit corporations under the statutes of the State of Florida.

One-hundred percent to Holy Cross Hospital, the use of which is restricted to the poor of Broward County, Florida.
