

Pursuant to the provisions of section 617.1006, Florida Statutes, this Florida nonprofit corporation adopts the following articles of amendment to its articles of incorporation:

The undersigned, the President and the Secretary of Iglesia Amor Y Paz, Inc. a Corporation certify that at a meeting held on 7/26/98, 1998, by the membership and at a meeting held on 8/02/98, 1998 by the Directors which was called for the purpose of amending the Articles of Incorporation of Iglesia Amor Y Paz, Inc., a Corporation, an appropriate majority of the members of each class entitled to vote authorized the following amendment of Article IV, section A of the Articles of Incorporation:

RESOLVED, that Article IV, section A of the Corporation's Articles of Incorporation is amended and shall now provide that:

A. The specific and primary purposes for which this corporation is formed is to operate an institution for religious worship without regard to race, color, creed or place of residence according to the principals of our faith. In furtherance of the purpose herein set forth, the corporation is hereby authorized and empowered to acquire, establish and maintain all necessary, real and personal property in buildings as may be necessary to fully carry out all the activities of the corporation.

RESOLVED, that Article XII of the Corporation's Articles of Incorporation is amended and shall now provide that:

Upon dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation shall be distributed to a non profit organization to be designated at time of dissolution.
