## SECOND AMENDMENT TO RESTATED ARTICLES OF INCORPORATION OF MORTON PLANT MEASE PRIMARY CARE, INC.

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned corporation adopts the following Second Amendment to its Restated Articles of Incorporation.

- 1. The Articles of Incorporation of Morton Plant Mease Primary Care, Inc., a Florida not for profit corporation (the "Corporation"), are hereby amended such that Morton Plant Hospital Association, Inc. shall become the member of the corporation.
  - 2. Definition 5 in Article I is hereby amended to read:
