#### ARTICLES OF AMENDMENT

The following provisions of the Articles of Incorporation of Marsh Landing at Sawglass Homeowners Association IV, Inc., a Florida non profit corporation, filed in Tallahassee, Florida on November 19, 1992, be and they hereby are amended in the following particulars:

1. Article XI, entitled "Amendment of Articles," is hereby amended and restated to read as follows:

"These Articles may be amended at any time by a majority vote of the Board of Directors at a special meeting of the Board of Directors at which a quorum of Directors is present and at which notice of the meeting has been given in accordance with the Bylaws."

- 2. The amendment was adopted by at least two-thirds (2/3) of the votes of the Members entitled to vote on the 30th day of Port 1, 2001.
- 3. The number of votes cast for the Amendment by the Membership entitled to vote was sufficient for approval.
