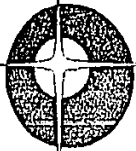

**ARTICLES OF INCORPORATION**  
**FOR**  
**YAHOVAH ELOHEEM MINISTRIES, INC.,**  
**WITH MYRTIS OLIQUE**

We, the undersigned, acting as incorporator(s) of a corporation pursuant to chapter 617, Florida Statutes, do hereby adopt the following Articles of Incorporation:

**ARTICLE 1**

NAME

The name of this religious corporation is YAHOVAH ELOHEEM MINISTRIES, INC. with Reverend Myrtis Olique

**ARTICLE 11**

PLACE OF BUSINESS/WORSHIP

The Post Office address of the corporation's principal office is 4525 SW 95th Avenue, Miami, Florida 33165.

**ARTICLE 111**

PURPOSE

The purpose for which this corporation is organized shall be:

1. To preach and teach the gospel of Jesus Christ as taught by Jesus, to make disciples of Jesus, to teach the Christian Faith, to be Ambassadors of Christ to the whole world, to heal the sick, to help the poor, baptising all those who confess Jesus as Lord of their lives in the name of the Father, Son and Holy Spirit;
2. To establish such other churches either within or without the State of Florida or such other places as the Holy Spirit directs.
3. To buy, sell, lease, mortgage or otherwise encumber, to hold or dispose of real and personal property of the corporation;
4. To further all religious and charitable work; and
5. To ordain men/women who have been called by God, so as to effectively minister the gospel where a license is required as recognition.

7. For such purpose to adopt and establish by-laws, rules and regulations in accordance with law and not inconsistent with this Articles of Incorporation.
8. Any and all lawful activities permitted under the law of the State of Florida, or any other State, County, Territory or principality.

## **ARTICLE IV**

This corporation shall not be less than three, the number to be fixed from time to time by the By-Laws and until so fixed the initial board of directors shall be (3) and the names and addresses of the persons who are to serve as the initial directors are as follows:
