The Family Center:

Community mental health/substance abuse services (prevention, intervention, and outpatient), therapeutic day care, and psychological assessments/evaluations.

- Total Youth Served 430

Foster Care Homes:

We provide two (2) long term foster care homes for male youth 10-18 years of age. These homes are designed to ensure each youth attains necessary skills to live and effectively function independently once they leave our care. They receive individual counseling, family therapy, social and personal skills building, group therapy, case management, crisis intervention, psychological evaluation, initial diagnostic assessment, psychiatric evaluations and attend school.
