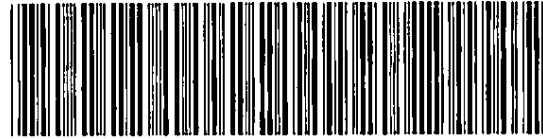

SECOND: The Articles of Incorporation of the Corporation were filed with the Florida Department of State on December 14, 1992, and the document number of the Corporation is N92000000751.


THIRD: Article I of the Corporation's Articles of Incorporation is hereby amended by deleting the existing Article I and replacing it with the following:
