THE CONSTITUTION OF CENTRO DE ENSEÑANZA PALABRA DE FE

The undersigned, acting as founder and incorporator pursuant to Chapter 617 of the Florida Statutes, adopt the following revised articles of incorporation on February 10, 2017 in Hialeah, Miami-Dade County, Florida.

ARTICLE I

The name of our church is Centro de Enseñanza Palabra de Felocated at 2201 W. 76 ST. Hialeah, Fl.

ARTICLE II

The purposes for which we incorporated are:

- 1-To preach and teach the gospel of our Lord and Savior Jesuschrist according to the interpretations established in our Norms of Faith and Bylaws.
- 2-To incorporate other churches and other means of communication and organizations inside and outside United States with the sole purpose of preaching the Gospel of Christ.
- 3-To ordaine Ministers who are in accord with our Norms of Faith and Bylaws.
- 4-To establish a k-12 school with daycare services to teach the Gospel of Christ plus math, sciences and reading and other subjects required by the state of Florida.

ARTICLE III

The duration of this incorporation shall be perpetual unless dissolved only by the President.

ARTICLE IV

The registered agent for the Incorporation is Carlos A. De Jesus with office at 2201 W. 76 ST. Hialeah, Fl. 33016.

ARTICLE V

This is a non-stock, non-profit incorporation.

ARTICLE VI

The qualifications for members, leaders and board members are defined in the Bylaws.

ARTICLE VII

The Organization goals shall be directed and administered by the pastor of the church. The pastor shall also serve as President of the Board of Incorporation. As executive he or she may administer finances, make banks deposits and write checks. In case of grievance the Pastor has veto power to over-ride other members of the board.

ARTICLE IX

In case of dissolution of the Organization, the residual assets shall be turned over to another exempt 501-c-3 organization and 170-c-2 of the IRS code of 1954 or as revised.
