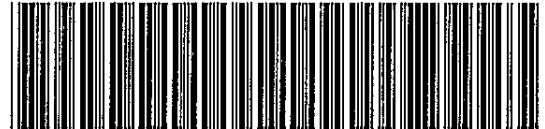



**SECOND ARTICLES OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR
COMMUNITY ASSOCIATIONS INSTITUTE OF FLORIDA, INC.**
