ARTICLES OF AMENDMENT To ARTICLES OF INCORPORATION OF

ARTICLE I - NAME

Pursuant to the provisions of section 617.1006, Florida Statues, this Florida Not For Profit Corporation adopts the following amendment to its articles of Incorporation:

The name shall remain the same.

ARTICLE II - PRINCIPLE OFFICE

The principal office of the Corporation is:

ARTICLE III - PURPOSE

This is a non-profit Corporation set up on a non-stock basis organized solely for general charitable purposes pursuant to the Florida Not For Profit Corporation Act.

The specific and primary purposes for which this Corporation is formed are to operate for the advancement of charity and for other charitable purposes, by the distribution of the funds for such purposes and particularly for speech and hearing.

The general purposes for which this Corporation is formed are to operate exclusively for such charitable purposes as will qualify it as an exempt organization under section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.

This Corporation shall not, as a substantial part of its activities, carry out propaganda or otherwise attempt to influence legislation; nor shall it participate or intervene (by publication or distribution of any statements or otherwise) in any political campaign on behalf of any candidate for public office.

Article IV - ELECTION OF OFFICERS AND DIRECTORS

- Section 1. Time of Election. The annual meeting of the club shall be held by the first meeting in April each year, at which time the Officers and three Directors shall be elected.
- Section 2. Term of Office. Officers shall serve for a period of one year beginning July 1 or until their successors take office. Directors shall serve for a period of two years beginning July 1, three Directors being elected each year. The Board of Directors shall consist of the elected Officers of the club and six Directors, three of whom shall be elected annually, at the annual meeting of the club, to serve for a two-year term. All Officers and Directors must be members in good standing.
- Section 3. Vacancies in Office. If an office becomes vacant during the year, the Board of Directors shall fill the office for the un-expired term.
- Section 4. Succession of Office. No Officer or Director may immediately succeed himself or herself in office, except that a Vice President. No person shall hold more than one elective office at the same time. However, the office of Secretary and/or Treasurer may be held by one person; and such person may not succeed himself or herself in office for more than two years.
- Section 5. Certification to Sertoma, Inc. Immediately following elections, the Secretary shall certify to the Executive Director of Sertoma, Inc. the names of the Officers and Directors who are to serve during the ensuing year.

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a non-profit fund, foundation, or corporation organized and operated exclusively for charitable purposes which has established its tax exempt status under Section 501(c) (3) of the Internal Revenue Code or corresponding section of any future federal tax code.
