

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF FEEDING FLORIDA, INC.

Pursuant to the provisions of section 617.1006. Florida Statutes, Feeding Florida, Inc., a Florida not-for-profit corporation (the *Corporation*), hereby adopts the following amendment to its Articles of Incorporation:

1. <u>Amendment Adopted</u>: ARTICLE IV of the Corporation's Articles of Incorporation is hereby amended in its entirety to read as follows:

ARTICLE IV

MEMBERSHIP OF THE CORPORATION

Each Member of the Corporation must be a Feeding America Food Bank ("FAFB"), as defined by Feeding America, a nonprofit corporation currently located at 161 N. Clark Street, Suite 700, Chicago, IL 60601, or the successor thereto ("Feeding America"). If any entity that is a Member of the Corporation ceases to qualify as an FAFB, the Corporation shall remove the entity as a Member of the Corporation as of the date such entity ceased to qualify as an FAFB. Further, a Member must pay annual dues to the Corporation as may be determined by the Board of Directors. The duration of a Member's membership in the Corporation shall be as set forth in the Bylaws of the Corporation.
