

ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF



OKALOOSA COMMUNITY DEVELOPMENT CORPORATION

Under the provisions of F.S. 617.1001, 617.1002 and 617.1006, this not – for – profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendment adopted: The first paragraph of Article II - Purposes shall be amended to state as follows: "The corporation is organized exclusively for charitable and educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code (or the corresponding portions of any future United States Internal Revenue Code), including, to the extent permitted by said Section 501 (c) (3), the redevelopment, promotion, up-grading, and rehabilitation of the cultural, historical, social, physical, and economic aspects of all counties of the State of Florida and to provide decent housing that is affordable in all counties of the State of Florida."
