The Board of Directors of Bella Vista Homeowners Association, Inc., held an annual meeting in accordance with the articles and bylaws of the Bella Vista Homeowners Association, Inc., and adopted by a two thirds vote of the Board of Directors the following amendments to the original Declaration of Covenants, Conditions, and Restrictions of Bella Vista Golf and Yacht Club, Inc., recorded in Book 1082 Page 1623 – 1657 of the Public Records of Lake County, Florida:

Article I Section 1 (a) is amended in full to read:

"Association" shall mean and refer to Sarabande Homeowners' Association, Inc., formerly known as Bella Vista Homeowners Association of Lake County, Inc., a Florida not-for-profit corporation.

Article I Section I (h) is amended in full to read:

"Owner" shall mean and refer to the record owner, whether one or more persons or entities, of the fee simple title to any single Lot with a single Living Unit which is situated on the Property, however notwithstanding any applicable theory of the law of mortgages, Owner shall not mean or refer to a mortgagee unless and until such mortgagee has acquired title pursuant to foreclosure or any procedure in lieu of foreclosure. Owner shall not include any builder, developer, homeowners' association or condominium association.

"Partial Owner" shall mean and refer to the record owner, whether one or more persons or entities, of the fee simple title to any portion of a Lot with a multiple Living Unit which is situated on the Property, however notwithstanding any applicable theory of the law of mortgages, Owner shall not mean or refer to a mortgagee unless and until such mortgagee has acquired title pursuant to foreclosure or any procedure in lieu of foreclosure. Partial Owner shall not include any builder, developer, homeowners' association, condominium association or timeshare association.

Article I Section 1(k) is added as follows:

"Undeveloped Lot Owner" shall also mean any person, persons or entities who or which has title to at least one undeveloped lot within the Property.

Article II Section 1's first sentence is amended in full to read;

Membership. Every person or entity who is an owner or a partial owner of a Lot on the Property shall be a member of the Association.

Article II Section 2 is amended in full to read:

Voting Rights. The association shall have three classes of voting memberships:

Class A. Class A Members shall be each owner. Class A Members shall be entitled to one vote for each lot.

Class B. Class B Members shall be each partial owner. Class B Members shall be entitled to a portion of one vote equal to their portion of a lot owned. For example if four living units are on one lot then the each partial owner on that lot shall be entitled to one vote.

Class C. Class C Members shall be any Undeveloped Lot Owners. Class C Members shall be entitled to one vote regardless of the number of undeveloped lots owned.

Proxy Voting. Proxy Voting is not permitted.

Article V Section 2 (h) is deleted.

Article V Section 11 is deleted.

The initial Assessment shall be a one-time assessment, and shall be due in addition to the Annual Assessments as provided herein. The new initial assessment fee shall be retroactive to January 1, 2005.
