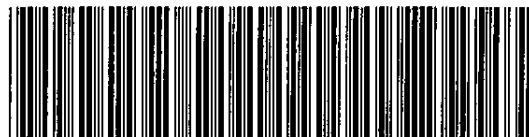

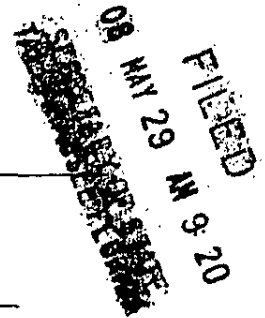

FIRST ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION
OF
CHANDELLE SUBDIVISION HOMEOWNERS' ASSOCIATION INC.

The Articles of Incorporation for Chandelle Subdivision Homeowners' Association, Inc. are hereby amended as follows:

ARTICLE I - NAME AND ADDRESS

The name of this corporation is Chandelle Subdivision Homeowners' Association, Inc, a non-profit corporation, and the address of the corporation is ⁵⁰⁰²~~1100~~ Chandelle Drive, Pensacola, Florida 32507.

ARTICLE III - PURPOSE

The purpose of this corporation is to form an association of homeowners living within Chandelle Subdivision; Chandelle Subdivision First Addition, Phase I; Chandelle Subdivision First Addition, Phase II; Chandelle Subdivision, Second Addition; and Chandelle Subdivision, Third Addition (hereinafter collectively referred to as "Chandelle Subdivision"); to preserve the residential quality of the land for themselves and for future owners and to provide for the maintenance of common areas in the Chandelle Subdivision together with any other activity permitted for a not for profit corporation under the laws of the United States and the State of Florida.

ARTICLE IV - MEMBERSHIP

Membership in the organization shall be set forth in the By-Laws of the corporation and in the Declarations of Covenants, Conditions and Restrictions of Chandelle Subdivision, Chandelle

Subdivision First Addition Phase I, Chandelle Subdivision First Addition Phase II, Chandelle Subdivision Second Addition, and Chandelle Subdivision Third Addition, together with any amendments thereto, duly recorded in the public records of Escambia County, Florida. Every Owner of a lot which is subject to assessment shall be a member of the corporation.

The Corporation shall have ~~two~~ one ~~classes~~ of voting membership:

Class A: Class A members shall be the Owners with the exception of the Developer.

Each Class A member shall be entitled to one (1) vote for each lot owned in the Chandelle Subdivision.

~~**Class B:** Class B members shall be the Developer who shall be entitled to three (3) votes for each lot owned. Class B membership shall cease and be converted to Class A membership when the total votes outstanding in the Class A membership equal the total votes outstanding in the Class B membership or on January 1, 1995, whichever occurs earlier.~~

Each owner of a lot shall be a Class A member entitled to one vote per lot owned in Chandelle Subdivision, as defined in Article III, above.

Except as expressly amended hereby, the Articles of Incorporation shall remain in full force and effect.
