## AMENDMENT TO THE ARTICLES OF INCORPORATION OF THE HOWARD GREENFIELD FOUNDATION, INC A NONPROFIT CORPORATION

The undersigned does hereby execute, acknowledge and diffe the following Amendment to the Articles of Incorporation of the Howard Greenfield Foundation, Inc.

- 1. The name of this nonprofit corporation is the Howard Greenfield Foundation, Inc.
  - 2. The Articles of Incorporation are amended as follows:
- a. Article III is hereby deleted, and the following new provision is hereby inserted in its stead:

"Article III.

The membership of this corporation shall consist of Howard Greenfield as the sole member. Upon Howard Greenfield's death, the Howard Greenfield Foundation, Inc. shall have no members."

- b. In all other respects, the Articles of Incorporation shall remain unchanged.
- 3. This Amendment was adopted by a written statement signed by the sole member of the Howard Greenfield Foundation, Inc. on April 13, 1997; pursuant to Section 617.1006 of the Florida Statutes.
  - 4. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.
