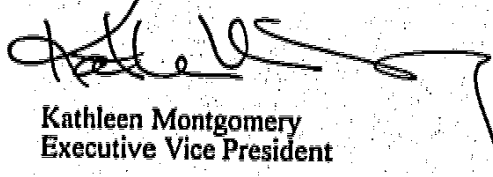
Dear Mr. Ferguson:

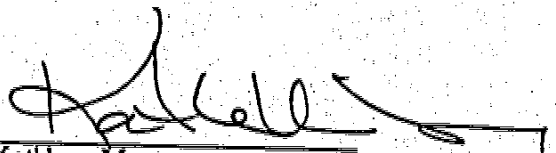

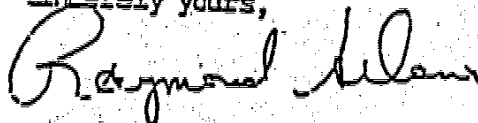
