We have received a Notice of Dissolution from your department.

Our not-for-profit corporation has been in existence since 1993 and each year we have renewed with the Division of Corporations.

This year, 1997, we did not receive a renewal notice in the mail. We called and was told that one would be sent. However, no renewal notice was sent to us. We called again and the same thing happened. Also, we were told that we really did not need this form because we were a not-for-profit organization funded by the City of Miami.

Finally, in April, our accountant told us that we needed to renew before May 1, 1997 and that we should call the Division of Corporations for a renewal form. We did as was suggested and never did get a form in the mail. Now we find that this corporation is dissolved because the department failed to send us the form that we needed.
