Existing Article III – PURPOSE and existing Article V – LIMITATION OF CORPORATE POWERS are to be amended, and new Article VIII – DISSOLUTION will be added.

ARTICLE III – PURPOSE

This corporation is organized as a church exclusively for charitable, religious, and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law), including but not limited to, for such purposes as the establishing and maintaining of religious worship; the evangelizing of the unsaved by the proclaiming of the Gospel of the Lord Jesus Christ; the educating of believers in a manner consistent with the requirements of the Holy Scriptures; and the supporting of missionary activities in the United States and in foreign countries.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Revenue Law).
