## Articles of Restatement for Glad Tidings of Jacksonville, Inc.

By these Articles, Glad Tidings of Jacksonville, Inc., hereby restates its Articles of Incorporation, as follows:

#### ARTICLEI

The name of the corporation is Glad Tidings of Jacksonville, Inc.

#### ARTICLE II

The street address of the initial and current registered office of this corporation is 6131 Terry Road, Jacksonville, Florida 32216, and the name of the current registered agent is Algerine B. Cox, whose address is 3355 Dorothea Road, Jacksonville, Florida 32216.

### ARTICLE III

The purpose of this corporation is as follows:

- a. To establish and maintain a place for the worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of the responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and abroad.
- b. To maintain this sovereign and independent Church (conducted under the legal auspices of Chapter 617, Florida Statutes insofar as the legal entity of the Church body pertains), recognizing that this Church shall remain dedicated to its Articles of Faith, and to that end, recognize the need to work in harmony and cooperation with such other churches, evangelistic associations, and ministers, as a means to the ends expressed in the Articles of Faith, recognizing their sovereignty under one sovereign, Jesus Christ our Lord.
- c. This corporation shall have the power to acquire and hold title in fee simple, in trust, or otherwise, to both real and personal property, and to improve, encumber, sell, convey and dispose of all such property in conformity with the By-laws of this corporation, and each and every power and right granted to Corporations Not for Profit under the laws of the State of Florida.

## ARTICLE IV

The members of the corporation shall be all members in good standing at any given time, as shown by the rolls of Glad Tidings of Jacksonville, Inc. Neither the members, or incorporators, of the corporation shall have any vested right, interest or privilege of, in or to the assets, functions, affairs or franchises of this corporation, or any right, interest, title or privilege which may be inheritable, or which shall continue after his or her membership ceases in the aforenamed corporation.
