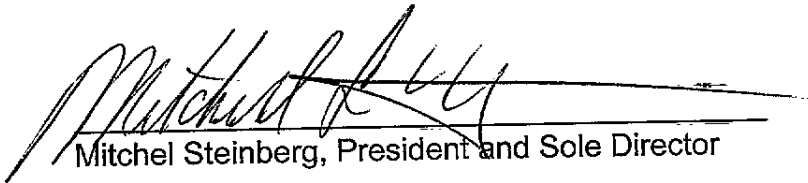
THE UNDERSIGNED, being the sole director and president of Health Quest International, Inc., does hereby amend its Articles of Incorporation as follows:

NAME**

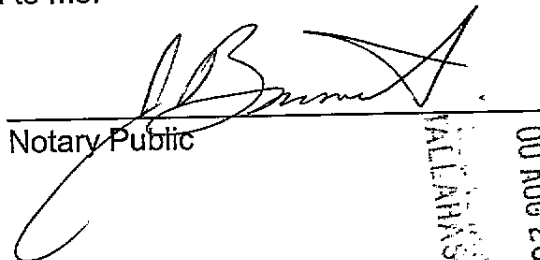
1. The name of this Company shall be Cause Events, Inc.
