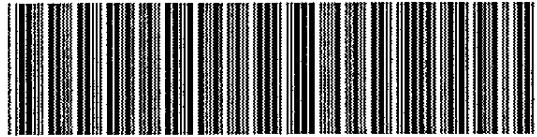

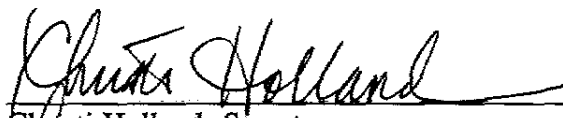
1. New Corporate Name: The new name of this corporation shall be:
