
**ARTICLES OF DISSOLUTION

Pursuant to Section 617.1403, Florida Statutes, Harbor View Condominium Association, Inc., a Florida not-for-profit corporation, submits the following articles of dissolution:

1. The name of the corporation as currently filed with the Florida Department of State is **HARBOR VIEW CONDOMINIUM ASSOCIATION, INC.** (the "Corporation").
2. The document number of the Corporation is N93000002162.
3. The file date of the Articles of Incorporation was May 12, 1993.
4. The members of the Corporation are not entitled to vote of the dissolution of the Corporation.
5. The dissolution of the Corporation was approved on December 30, 2015 by the unanimous written consent of the Corporation's Board of Directors (consisting of three Board of Directors members), in accordance with Sections 617.0821 and 617.1402(2), Florida Statutes.
6. The dissolution of the Corporation is effective immediately following the recordation of the Certificate of Termination of Harbor View Condominium.
