Pursuant to the provisions of section 617.1006, Florida Statutes, the Articles of Incorporation of **DADE COUNTY FOUNDATION FOR INTERSCHOLASTIC SPORTS, INC.**, a Florida not for profit corporation (the "Corporation") are hereby amended according to these Articles of Amendment:

**FIRST:** The name of the Corporation is **DADE COUNTY FOUNDATION FOR INTERSCHOLASTIC SPORTS, INC.**


**SECOND:** Article I of the Articles of Incorporation is amended in its entirety to read as follows:
