OF  
BELIEVER'S OF CHRIST TEMPLE MINISTRIES, INC.  
(A CORPORATION NOT FOR PROFIT)**

**AN AMENDMENT OF ADDITION TO ARTICLE XIII  
AMENDMENTS**

**Except for Articles II, III and this Article XIII, these Articles of Incorporation may be amended in the manner provided by law. The Board of Trustees shall approve every such amendment.**

**Articles II, III, and this Article XIII may be amended only by unanimous approval of the Board of Trustees entitled to vote thereon at a regular or special meeting of the Board of Trustees called for such a purpose or given a (14) day notice prior thereto by certified mail, return receipt requested.**

**A resolution signed by all trustee members entitled to vote together with a certificate signed by the President and Secretary shall be deemed sufficient evidence of approval of any amendment to the Articles requiring unanimous approval.**

**AN AMENDMENT OF ADDITION TO ARTICLE X  
BY - LAWS**

**The By - Laws of this corporation, or any alteration or amendment thereof, shall be made and adopted by the Board of Trustees. Such By - Laws or alterations or amendments thereof shall be passed with a two third vote approval of this board.**
