

ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION

Pursuant to the provisions of Sections 617.1001, 617.1002, and 617.1006 of the Florida Statutes, the undersigned corporation adopts the following Articles of Amendment to its Articles of incorporation, filed June 28, 1993, #N93000002895.

SECOND: Article I of the Articles of Incorporation is hereby amended in its entirety as follows:

Article I

Name and Principal Office
