TO THE ARTICLES OF INCORPORATION OF

THE ISLE OF TUSCANY NEIGHBORHOOD ASSOCIATION, INC

A Not For Profit Corporation, Incorporated Florida, 1993

A Corporation Not-For-Profit Under the Laws of the State of Florida

The Articles of Incorporation of The Isle of Tuscany Neighborhood Association, Inc. were filed with the Florida Secretary of State on June 29, 1993. The same Articles of Incorporation were recorded in Official Records of Saint Lucie County, Florida at Official Records Book 850, Page 484, et. seq. The same Articles of Incorporation are hereby amended as adopted by 75 % of the membership at the Members Meeting held on November 11, 2014.

Article X Sections 10.4 and 10.5 are amended to read as follows:

ARTICLE X AMENDMENTS

- §10.4 <u>Approval</u>. Except as elsewhere provided, the approval of a resolution for the adoption of a proposed amendment to these Articles shall require the affirmative vote of not less than fifty-one percent (51%) of the total votes cast, in person or by proxy, at a duly convened meeting of the members.
- §10.5 <u>Limitation</u>. Provided, however, that no amendment shall make any changes in the qualification for membership nor in the voting rights or property rights of members, nor any changes in Sections, 4.3, 4.4, and 4.5 of Article IV, entitled "Purposes and Powers of the Association", without approval in writing by all members.

(The balance of Article X remains unchanged)

- 2. The foregoing amendments were to the Articles of Incorporation of The Isle of Tuscany Neighborhood Association, Inc. was adopted by 75 % of the Members at the Members Meeting held on November 11, 2014, which vote was sufficient for approval.
- 3. All provisions of the Articles of Incorporation of The Isle of Tuscany Neighborhood Association, Inc. are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
