## CERTIFICATE OF AMENDMENT TO THE ARTICLES OF INCORPORATION FOR ISLE OF LOMBARDY NEIGHBORHOOD ASSOCIATION, INC.

The Articles of Incorporation for Isle of Lombardy were recorded in the public records of St. Lucie County, Florida at Official Records Book 0850, Page 0529 et. seq., and amended at Official Records Book 855, Page 2125, et. seq. The same Articles of Incorporation are hereby amended as approved by the Board on June 21, 2021 and by at least 92 affirmative votes of the members.

1. Article IV, §4.4 is amended to read as follows:

## ARTICLE IV PURPOSES AND POWERS OF THE ASSOCIATION

§4.4. Borrow money, and mortgage, pledge, deed in trust, or hypothecate any or all of its real or personal property as security for money borrowed or debts insured.

(The remaining balance of Article IV remains unchanged.)

- 3. All provisions of the Articles of Incorporation for The Isle of Lombardy are herein confirmed and shall remain in full force and effect, except as specifically amended herein.
