**SUNCOAST FULL GOSPEL TABERNACLE, INC.**

Pursuant to the provisions of Section 687.1006, Florida Statutes, this corporation adopts the following articles of amendment to its Articles of Incorporation:

**PREAMBLE**

For the purpose of establishing and maintaining a place for the worship of Almighty God, our Heavenly Father, to provide for Christian fellowship for those of like precious faith, where the Holy Spirit may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means, both at home and in foreign lands; we, the members of this assembly, do hereby recognize ourselves as a local assembly in fellowship with and as a part of the General Council of the Assemblies of God, with headquarters in Springfield, Missouri, and also of the Peninsular Florida District Council of the Assemblies of God, with headquarters in Lakeland, Florida, and that we do hereby adopt the following articles of church order and submit ourselves to be governed by them.

**FIRST:** Amendment adopted: Article I: Corporate Name

1. The name of the corporation shall be:

**SUNCOAST ASSEMBLY OF GOD OF HOLIDAY, INC.**

Amendment adopted: Article VII: Distribution of Assets

1. The following paragraphs shall be added to Article VII:

In the event this district council shall cease to function for the purposes herein set forth, then all property, real or chattel, and all assets remaining after satisfying debts and obligations, shall revert to the parent body, **THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD**, a Missouri not-for-profit corporation, with headquarters at Springfield, Missouri. The General Council of the Assemblies of God shall have full authority to sell such property and to use the proceeds derived therefrom for the extension

of the work of the Assemblies of God.

In the event of cessation of this District Council, its board of trustees shall transfer all properties and any remaining assets, in accordance with the foregoing provisions within one year after the date of such cessation. If such transfer is not made within the time prescribed above or if the aforesaid General Council shall be unable or unwilling to accept the aforesaid transfer, then disposition thereof shall be made by the court of the county in which the district council headquarters office is located in provided that in such case proceeds of the dissolution shall be distributed to organizations having purposes nearest the purposes of the Assemblies of God.

**SECOND: Adoption of Amendment**

At a meeting on May 12, 1999, the Board of Directors unanimously adopted the foregoing changes in the Articles of Incorporation, which was presented to the members and unanimously adopted on the 6 day of June, 1999.


