*Pursuant to the provisions of section 617.1006, Florida Statutes, this corporation adopts the following articles of amendment to its articles of incorporation.*

**FIRST:** Amendment adopted: Preamble

1. the following lines shall be deleted from the Preamble:

“...we do hereby recognize ourselves as a local assembly in fellowship with and as a part of the General Council of the Assemblies of God, with headquarters in Springfield, Missouri, and also of the Peninsular Florida District Council of the Assemblies of God, with headquarters in Lakeland, Florida,...”

Amendment adopted: Article 1: Corporate Name

1. The name of the corporation shall be:

**SUNCOAST FULL GOSPEL TABERNACLE, INC.**

Amendment adopted: Article VII: Distribution of assets

1. The following paragraphs shall be deleted from Article VII

“ In the event this district council shall cease to function for the purpose herein set forth, then all property, real or chattel, and all assets remaining after satisfying debts and obligations, shall revert to the parent body, THE GENERAL COUNCIL OF THE ASSEMBLIES OF GOD, a Missouri not-for-profit corporation, with headquarters at Springfield, Missouri. The General Council of the Assemblies of God shall have full authority to sell such property and to use the proceeds derived therefrom for the extension of the work of the Assemblies of God.

In the event of cessation of this District Council, its board of trustees shall transfer all remaining assets, in accordance with the foregoing provisions within one year after the date of cessation. If such transfer is not made within the time prescribed above or if the aforesaid General Council shall be unable or unwilling to accept the aforesaid transfer, then disposition thereof shall be made by the court of the county in which district council headquarters office is located in provided that in such case proceeds of the dissolution shall be distributed to organizations having purposes nearest the purposes of the Assemblies of God.

Amendment adopted: Article X: Amendment of Articles

1. The following paragraph shall be added to Article X

The by-laws of this assembly may be amended by a simple majority vote of members

present at any regular or special business meeting, except as otherwise indicated herewith; any article of affiliation, or article pertaining to purchases of property, real or chattel in excess of \$5000.00, disaffiliation, dissolution, any amendments to these specific exclusions will require a vote of 2/3 of the members present.

**SECOND:** Adoption of amendment

At a meeting June 3, 2001, the Board of Directors unanimously adopted the foregoing changes in the Articles of Incorporation, which was presented to the members of this assembly and unanimously adopted on this 3rd day of June, 2001.
