

## ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF SAINT FRANCES OF ASSISI CATHOLIC MISSION, INC.

The Articles of Incorporation of Saint Frances of Assisi Catholic Mission, Incorporation of Saint Frances of Assis Catholic Mission of Saint Frances of Assis Cat

1. Article III is hereby amended to read:

This corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purposes the making of distributions to organizations under Section 501(c)(3) of the Internal Revenue Code (or any corresponding section of any future federal tax code).

2. Article VII is hereby amended to read in its entirety as follows:

Upon the dissolution of this corporation its assets shall be distributed for one or more exempt purposes within the meaning of Section 501 (c)(3) of the Internal Revenue Code or corresponding section of any future federal tax code or shall be distributed to the federal government or to a state or local government for a public purpose.

- 3. Article XIII is hereby amended to read in its entirety as follows: =
- a) No part of the net earnings of the corporation shall enure to the benefit of or be distributable to its members, trustees, directors, officers, or any private persons except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payment and distribution in furtherance of Section 501(c)(3) purposes.
- b) No substantial part of the activities, the corporation shall carrying on propaganda or otherwise attempting to influence legislation and the corporation shall not participate in or intervene in (including the publishing or distributions of statements) for any political campaign on behalf of or in opposition to any candidate for public office.
- c) Notwithstanding any other provisions of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code or by corporation contributions to which are deductible under Section 170(c)(2) of the Internal Revenue Code.

- The foregoing amendments were adopted and effective April 1, 1999.
