
**THE PERMANENT ENDOWMENT FUND COMMITTEE OF THE

*Pursuant to section 617.1403, Florida Statutes, this Florida not for profit corporation submits the following  
Articles of Dissolution:*

- FIRST: The name of the corporation is THE PERMANENT ENDOWMENT FUND COMMITTEE OF THE COMMUNITY UNITED METHODIST CHURCH OF OLDSMAR, FLORIDA, INC.
- SECOND: On July 25, 2003, a meeting of the members of the corporation was held, at which time a resolution to dissolve was adopted. The number of votes cast for dissolution was sufficient for approval.
- THIRD: The resolution of the members of the corporation directed that all remaining assets of the corporation should be disposed of in a manner consistent with the requirements of the initial Articles of Incorporation of the corporation, and further directed the last remaining Directors of the corporation to complete transfer of any assets.
- FOURTH: Having completed all business of the corporation, the meeting of the members was concluded.
