I was astonished to receive a Notice of Dissolution or Revocation for The Frederic A. and Lucille G. Doppelt Family Foundation, Inc. (P.O. Box 49948 Sarasota, Florida 34230-6948) yesterday. A check (#299) was issued and enclosed in the 2006 Not-For-Profit Corporation Annual Report (see attached copy) which was sent to the Division of Corporations, P.O. Box 1500, Tallahassee, FL 32302-1500 on April 28, 2006.

Unfortunately, due to a critical illness of my husband, (he has been placed on kidney dialysis) I did not confirm if the check was cashed until after receiving your notice yesterday. The check has not been cashed. Most puzzling. Is there a way to ensure receipt by mail since a certified letter may not be sent to a post office box? I am requesting reinstatement, active and in good standing, for the above noted family foundation, FEI number 58-2071025. To that end, I am enclosing another check #305 (I have placed a cancellation order for the original check) in the amount of \$61.25.
