

ARTICLES OF INCORPORATION of PAINT ST. PETE PROUD, INC.

The undersigned, President of Paint St. Pete Proud, Inc., acting pursuant to a two-thirds majority vote by the entire board of directors of Paint St. Pete Proud, Inc. hereby amends the Articles of Incorporation of the Corporation read as follows:

**ARTICLE I - CORPORATE NAME**

The name of the corporation is St. Pete Proud, Inc.

**ARTICLE II - PURPOSE**

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary, and educational within the meaning of section 501(c)(3) of the Internal revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. These purposes include beautifying the homes of the elderly, economically disadvantaged and disabled within the City of St. Petersburg, at no charge or cost to the individual homeowners. Beautifying may include providing landscaping, repair, clean-up, trash removal and other services needed to improve and beautify the appearance of the property.


Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

All other Articles contained in the Articles of Incorporation remain unchanged.

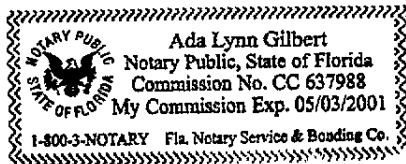


