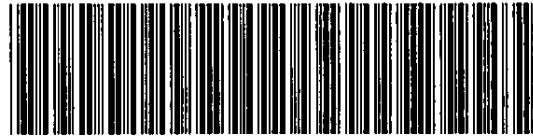

Pursuant to the provisions of Section 617.1006, Florida Statutes, the undersigned Judicial Equality Foundation, Incorporated, a Florida, nonprofit corporation, filed with the Florida Secretary of State at file number N93000003503, (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: ARTICLE I. – NAME: The Name of the Corporation is hereby amended in its entirety to change its name to:
