

Notwithstanding any other provision of these Articles, the Corporation shall not carry on any othe activities not permitted to be carried on (a) by a corporation exempt from federal income tax under Section 501(c)( of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation section of any future federal tax code.

C. Not withstanding anything to the contrary contained in the Articles of Incorporation, upon the dissolution of this Organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3 of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, for a public purpose.
