Thank you for your response concerning EZRA MINISTRIES, INC. After the above letter was received, your office was contacted to see if we could get some kind of a break on the reinstatement of EZRA MINISTRIES, INC. We were asked to write a letter of explanation for the oversight of filing annual reports. The following may help to explain the oversight.

EZRA MINISTRIES, INC's address changed in 1996. At this time, we wrote the Division of Corporations, State of Florida, reporting an address change and asking for a filing packet (copy attached). We never received the packet and we were remiss in following up. In '97 we did not receive a packet, however, in '98 we became very concerned and wrote again. A packet was received and the filing was sent on 4/15/99. It was returned with the above letter stating that EZRA MINISTRIES had been dissolved for failure to file annual reports since '96.

EZRA MINISTRIES, INC. is a NON-PROFIT that through its gifts, partially support several missionaries in Holland (The Netherlands). All monies go for these missionaries and their work. The reinstatement fee first requested would be impossible to handle so we are asking to be reinstated for the \$245.00 if possible.

Attached is a check for \$245 and the annual report that was filed on 4/15/99. I have also enclosed a copy of our request for address change dtd 6/10/96 and copies of the minutes of the annual Board Meetings held each year since 1996. We request that EZRA be considered an active NON-PROFIT and our request for relief on the fees be considered. We regret that we were remiss in following up on the annual packets each year and will be consistent going forward.
