**ARTICLES OF AMENDMENT TO THE
ARTICLES OF INCORPORATION OF
FLORIDA INSTITUTE FOR MEDICARE ADVOCACY, INC.**

Pursuant to the provisions of Section 617.1001 of the Florida Statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is the:

Florida Institute for Medicare Advocacy, Inc.

The following Amendments to the Articles of Incorporation were adopted by the Directors of the Corporation on December 11, 2000, in the manner prescribed by the Florida Not for Profit Corporation Act.

2. A new Section 3.3 is added to Article 3 as follows:

3.3 Additional Specific Purposes:

A. To educate the public about and establish trusts in accordance with Federal and State laws for the management, investment and distribution of principal and income for the sole benefit of disabled individuals who are beneficiaries of such trusts during their lifetimes.

B. To educate the public about and establish trusts in accordance with Federal law requirements for the management, investment and distribution of principal and income to assist workers compensation claimants and other claimants to meet their obligations under provisions of the Medicare laws as they apply to settlements and recoveries by such claimants.

C. To perform such activities and events as may be necessary in order to carry out these additional purposes.

3. A new Section J is added to Article 6 as follows:

A. To act as a trustee under Section 617.2101 of such trusts and entities as allowed by law and authorized by the Board of Directors of the Corporation.

4. The Corporation has no members, therefore only the Directors of the Corporation voted on the Articles of Amendment.
