The Gospel Truth Pentecostal Church  
Amendment to Be Added.

A. The purposes for which the Gospel Truth Pentecostal Church is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt federal income tax under Section 501(C)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

C. In the event of dissolution the residual assets of the organization will be turned over to one or more organization which themselves are exempt as organization described in Section 501(C)(3) and 170(C)(2) of the Internal Revenue Code of 1986 or corresponding sections of any prior or future Internal Revenue Code or to the Federal, state, or local government for exclusive public purpose.
