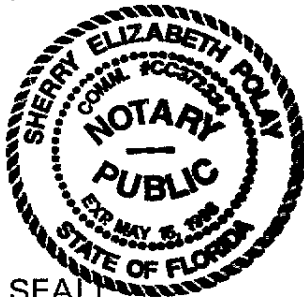
- (1) The name of the Corporation is LAKELAND REBOUNDERS, INC.

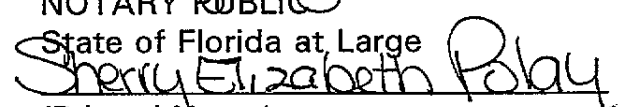
