

ARTICLES OF AMENDMENT

The Articles of Incorporation of NORTH AMERICAN USERS' GROUP OF APPLIED SYSTEMS, INC., a Florida corporation, were filed with the Florida Secretary of State on September 8, 1993, under Document No. N93000004137.

1. The following provision of the Articles of Incorporation is hereby amended in the following particular:

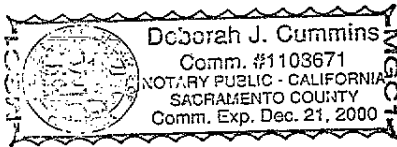
