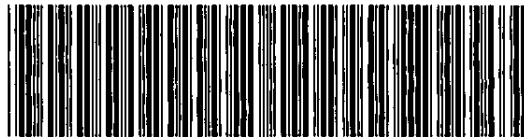

Child Watch of North America has expanded its range of services and has decided to amend its Bylaws to include these particular services. The Bylaws will now allow Child Watch to offer abuse and trauma therapy to children, adults, military personnel and veterans and law enforcement individuals. Child Watch staff can offer these services directly by any qualified staff or refer abuse and trauma victims to outside mental health professionals. Child Watch staff can provide these services for a fee to cover costs or provide the services on a pro bono basis. Child Watch management can contact mental health professionals and request their services for victims on a pro bono basis or cover the costs for victims from general or specific funds raised if available.

This amendment is intended to broaden the reach and scope of the services provided by Child Watch. It is not intended to eliminate the original services provided from its inception.
