

The following language shall be deleted in its entirety from the Articles of Incorporation: Child Watch of North America has expanded its range of services and has decided to amend its Bylaws to include these particular services. The Bylaws will now allow Child Watch to offer abuse and trauma therapy to children, adults, military personnel and veterans and law enforcement individuals. Child Watch staff can offer these services directly by any qualified staff or refer abuse and trauma victims to outside mental health professionals. Child Watch staff can provide these services for a fee to cover the costs or provide the services on a pro bono basis. Child Watch management can contact mental health professional and request their services for victims on a pro bono basis or cover the costs for victims from general or specific funds raised if available. This amendment is intended to eliminate the original services provided from its inception.

The first sentence of Article III of the Articles of Incorporation shall be deleted in its entirety and replaced with the following: The Corporation is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of of any future federal tax code.
