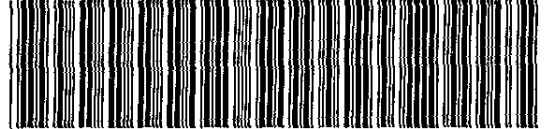

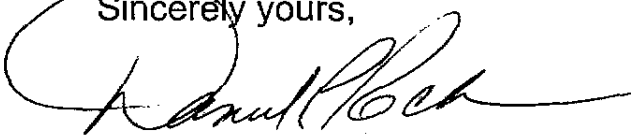

## 2002 AMENDMENT TO ARTICLES OF INCORPORATION

BE IT RESOLVED, that Articles 1, 6, 7, 8 and 9 of the Articles of Incorporation of **SKYBOUND MINISTRIES, INC.**, which were filed on November 2, 1993, and assigned Charter # ~~W93000005025~~, and are hereby Amended as follows:

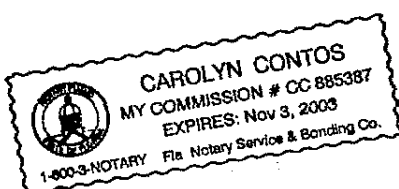
