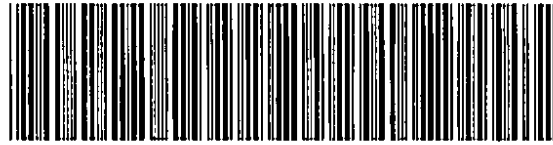

ADDING ARTICLE XV : ORDAIN MINISTERS
