ARTICLES OF AMENDMENT TO ARTICLES OF INCORPORATION OF

ST. PETERSBURG-CLEARWATER AREA FILM COMMISSION, INC.

Pursuant to Sections 617.1002 and 617.1006 of the Florida Statutes, and pursuant to the provisions of Article XI of the Articles of Incorporation, the Articles of Incorporation of ST. PETERSBURG-CLEARWATER AREA FILM COMMISSION, INC. (the "Corporation") are hereby amended as follows:

Article I is hereby amended by deleting the current provisions of Article I in their entirety and substituting in their place the following:

"The name of the Corporation shall be:

ST. PETERSBURG-CLEARWATER AREA FILM COMMISSION, INC."

Article V is hereby amended by deleting the current provisions of Article V in their entirety and substituting in their place the following:

"The Corporation shall be governed by a Board of Directors who shall possess the sole voting rights with respect to the Corporation. The number of directors shall be that number that is specified in the Bylaws of the Corporation from time to time; provided, however, such number shall never be less than three (3) directors. The directors shall be selected as provided in the Bylaws of the Corporation."

- Except as hereby amended, the Articles of Incorporation of the Corporation are hereby ratified and affirmed.
- No members of the Corporation are or were entitled to vote on the aforementioned amendments, and in accordance with the provisions of Article XI of the Articles of Incorporation of the Corporation, a majority of the directors of the Corporation duly adopted the aforementioned amendments on Aug. 19 19 1996.
