**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION
OF
TRI-COUNTY CITIZENS AGAINST DISCRIMINATION, INC.
A NONPROFIT CORPORATION**

1. The following provision of the Articles of Incorporation of TRI-COUNTY CITIZENS AGAINST DISCRIMINATION, INC., A NONPROFIT CORPORATION (the "Corporation"), a corporation duly organized and in good standing under the laws of the State of Florida, as evidenced by Charter No. 93000005612 issued on December 10, 1993, is hereby amended in the following particulars:

ARTICLE FOUR be and it hereby is amended to read as follows:

1. **PURPOSES**

A. The purposes for which the corporation is organized are exclusively charitable, literary and educational within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

B. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from income tax under section 501(c)(3) of the internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.
